A MOTION was made by Mr. Nest, and seconded by Mr. Miller, that the ONSRC fiscal year be changed from Sep 1<sup>st</sup> thru Aug 31<sup>st</sup>, TO calendar year Jan 1<sup>st</sup> thru Dec 31<sup>st</sup>, effective Jan 1, 2015, AND that the terms of SRC officer and appointments remain as Sep 1<sup>st</sup> as the initial date of appointment. The motion was approved unanimously.

 Mr. Chapman requested that Mr. Stuver submit an email notification to all fitness test administrative volunteers, that they will receive a \$25 payment for their services on Aug 1, 2015. This payment was approved at the Dec 16, 2014 SRC meeting.

## **WORK SESSION: (Strategic Planning)**

#### ANNUAL CALENDAR

A draft annual planning calendar was submitted by Mr. Stuver. Month-by-month discussion enhanced the events and activities planned for the next year. See attached.

#### DDI – Mansfield

Mr. Nest announced that he planned to appoint Mike Hill as the Mansfield DDI. Mr. Hill also serves as the Mansfield DRA.

#### FITNESS TEST

A second fitness test opportunity should be scheduled during fall 2015. The date Sunday, Oct-11 was selected.

ACTION: Mr. Stuver will pursue selection of an appropriate facility.

## ASSESSORS / ASSESSMENTS

Mr. Tomazic initiated a discussion regarding training of assessors. The only assessor course offered at this time is the state assessor course. Mr. Tomazic recommended that the "Mentor" course be utilized for instructors and other mentors, and that these trained "Mentors" be assigned to D&G assessments for referees through grade 7A.

Consensus that an appointed position should be created to manage a mentoring program with multiple tracks. Mr. Nest suggested that this position report to the SDA.

#### REFEREE ADVANCEMENT

Discussion: how to identify and track those referees interested to advance. Consensus that the declaration process should be renewed, with the following annual process:

#### STATE REFEREE

- 1. Referee declares interest to advance to state referee by submitting an application by Dec-1<sup>st</sup>.
- 2. Referee attends an appropriate state upgrade clinic in December.
- 3. The remainder of the following year would serve as the referee's "candidate" year to fulfill remaining upgrade requirements.

#### 7A REFEREE

- 1. Referee declares interest to advance to 7A referee by submitting an application by Mar-1<sup>st</sup>.
- 2. Referee attends an appropriate 7A upgrade clinic.
- 3. The remainder of the year would serve as the referee's "candidate" year to fulfill remaining upgrade requirements.

ACTION: Mr. Stuver will send a draft of the referee grade / clinic requirements matrix for consideration. The purpose is to prepare a document that will provide guidance to referees and administrators regarding requirements for each referee level.

#### MISCELLANEOUS DISCUSSION

- Mr. Miller suggested the creation of an FAQ webpage on the ONSRC website.
- Recognition of our referees who are achieving success regionally and nationally should be announced at clinics and posted on the ONSRC website.
- o Mr. Chapman asked Mr. Miller to purchase shirts for the two referees who will attend the youth national championships.
- o Mr. Stuver presented the youth regionals HOD report (see attached).
- Mr. Miller announced that Mr. Chapman has been selected to the USASA Hall of Fame! The induction will occur in California on Oct-10<sup>th</sup>.

SUBJECT: State Delegation Report: Youth Region II Championships

Ohio-North was well represented with a group of quality referees, assessors and mentors at the Region II Youth Championships held at the USA Youth Soccer Complex (Appleton, WI) and Southwest Park (De Pere, WI) from June 19<sup>th</sup> through June 24<sup>th</sup>.

Our delegation received a total of <u>113 assignments</u>, with 29 of those assignments as "referee". It is important to note that there were 31 assignments as the "4<sup>th</sup> official", and all except one of our delegation, received assignments as the "4<sup>th</sup> official". This is evidence of the importance that we continue to include 4<sup>th</sup> official assignments during our state cup tournament to properly prepare our regional delegation.

Our assessors / mentors were also very active with a total of 25 assessments.

MacQueen – 7 assessments, including a semi-final

Miller - 6 assessments

Stoica - 6 assessments

Stuver – 6 assessments, plus 1 shadow assessment (with Tim Deters) during a semi-final match

The following "9" referees received **semi-final assignments**: Beck, Danut, FikarB, FikarK, Marzilli, Reese, Saini, Moliterno, Suarez, Vass.

The following "4" referees received assignments to **championship matches**: Beck (AR), FikarB (AR), Marzilli (REF), Reese (AR).

The tournament agenda included the first-day rookie meeting, followed by the referee instructional clinic and the outdoor sessions. Outdoor sessions were conducted on a local high school stadium field and included: AR drills, Referee positioning drills, 4<sup>th</sup> official duties, general referee logistics and procedures.

Clinic instruction throughout the event was led by Fotis Bazakos (PRO Referee), Sorin Stoica (PRO Referee), and Tom Supple (Former MLS AR).

There were several mentoring sessions at the field complexes that were led by instructors (above) or mentors. Groups of referees observed multiple matches with these mentors, and used these activities as opportunities to review and discuss match events.

Brian Miller attended this event as a member of the Region II staff. While Brian had a "roving mentor" role and was there as a member of the Region II staff, his presence and mentoring for Ohio-North referees was ever present and very much appreciated.

The OHN delegation performed well on and off the field, and displayed positive support and camaraderie. Even our "rookies" did well! Two of the five "rookies" (Danut and Saini) received "AR" assignments for semi-final matches.

#### LOGISTICS:

This year's travel to / from De Pere, WI was uneventful. Brian Miller coordinated the rental of 5 vehicles through Enterprise, with discount via Progressive Insurance. The pick-up / drop-off process was very efficient, and we were able to effectively transport 20 people in 5 vehicles.

The dorm rooms were college suites. Suites consisted of 2-person rooms, a large common area, plus a small kitchen area.

Breakfast meals were a part of the referee expense at St. Norbert College. Referees ate dinner at local establishments within walking distance.

The Region II dinner was held on campus at St. Norbert College on Friday night. The Referee Delegation dinner was held at the Prime Quarter in Green Bay on Saturday evening. The Ohio-North Delegation dinner was held at Nakashima of Japan, and a very special thank you to Paul Emoff and Bob Riggs of the state youth soccer association (OYSAN) for their sponsorship of this dinner. It was a very nice dinner and their support of the Ohio-North referee delegation is truly appreciated!

Each referee was presented with two OYSAN shirts, and a packet of OYSAN flipping coins.

It was a privilege to serve as the HOD, and I would welcome the opportunity to repeat in this role for future trips to Regionals!
